**COVID-19 Protocols at Belmont Village Westwood:** As the Westwood Community Council has resumed in-person meetings at Belmont Village Westwood, and in consideration of Belmont’s sensitive population as a senior residential and healthcare facility, all WCC members and guests entering Belmont for the first time must check into a lobby kiosk, type in their first and last name, answer a few health status questions, scan their vaccination card showing dates of full vaccination, including booster (if eligible), and take an instant forehead temperature check. Kiosk will photograph front and back of vaccination card. Upon approval of photos for legibility, visitor’s name will be added to Belmont’s pre-approved guest list. On subsequent visits, only an instant temperature check and answering a few health status questions will be required. All unvaccinated persons may conduct an on-site, self-administered COVID-19 rapid test, using either a rapid test kit they provide and self-administer on-site, or they may purchase a rapid test kit from Belmont (\$15 fee, cash or check only) and self-administer on-site, with results given in 5-15 minutes. Upon a negative rapid test result, instant temperature check, and answering a few health status questions, visitors will be admitted. In accordance with the Governor’s mandate and L.A. County Health regulations, Belmont Village Westwood, as a senior residential and healthcare facility, requires face masks to be worn by all persons at all times while inside the facility, unless eating or drinking.

**WCC PUBLIC COMMENT POLICY:** In accordance with its Bylaws, the Westwood Community Council (WCC) shall provide an opportunity in open meetings for members of the public to address the WCC on agenda items at the time the respective item is considered. Individual testimony on agenda items shall be limited to two (2) minutes per person. Public comments on all other non-agendized topics of interest to the public which are within the subject matter and jurisdiction of the WCC shall be made during the General Public Comment period, and shall be limited to two (2) minutes per person and up to ten (10) minutes per subject. However, the WCC Chair has the discretion to modify the time allotted for each agenda item and each speaker depending on the number of speaker request cards received and the time available for each agenda item and each non-agendized topic. Items may be called in any order at the discretion of the Chair.

**EVERY PERSON WISHING TO ADDRESS THE WESTWOOD COMMUNITY COUNCIL (WCC) ON ANY AGENDA ITEM MUST COMPLETE A SPEAKER'S REQUEST CARD AND SUBMIT IT TO THE WCC CHAIR PRIOR TO THE WCC'S CONSIDERATION OF THAT ITEM.** The WCC agenda is posted for public review at the Westwood Branch Public Library, 1246 Glendon Avenue, Los Angeles, CA 90024, and at [www.westwoodcommunitycouncil.org](http://www.westwoodcommunitycouncil.org) online.

Belmont Village Westwood is located at 10475 Wilshire Boulevard, next to the Westwood United Methodist Church main sanctuary (east of Warner Avenue). For guests driving a personal vehicle, free self-parking is available in the Belmont Village garage, accessed from Wilshire Boulevard. Enter driveway, proceed under the overhang, and turn right into the garage. Park on levels P2, P3, or P4 and take the elevator or stairs located near southwest corner of the garage up to the first floor. The Town Hall community room is located on the first floor, across the elevator in the main lobby. Belmont Village also can be reached by all bus lines serving Wilshire Boulevard, including Metro Line 20 and Metro Rapid Line 720. (Belmont is located one and one-half blocks west of the Beverly Glen bus stop.) Bicycle parking is located inside the garage on level P1, along the railing. Belmont Village is a fully ADA accessible facility. Please note Belmont Village Westwood's COVID-19 protocols detailed above.
